



9/11 EVIDENCE DESTRUCTION

WHAT DOES GUILTY DEMEANOR LOOK LIKE?

It has been said that it's often not the crime, but the cover-up that earns jail time.

Here is a *partial* list of 9/11 evidence that has been altered, destroyed, suppressed, and/or classified since the attacks: **(for copy with Live Links to news articles, interviews, evidence: See back page)**

- ▶ Shortly before noon on September 11, 2001, 16 people at New York's Air Traffic Control Center, including six controllers who dealt with hijacked flights, made an audio recording of their recollection of what had transpired. An FAA "quality assurance manager" crushed the tape in his hands, shredded it into multiple pieces, and distributed the pieces in multiple trashcans before taking the trash out – after a message was sent to retain all recordings and relevant data. (Washington Post, 5/7/04, NYTimes 5/7/04)
- ▶ It's claimed by the FBI and the 9/11 Commission that not one of the 4 black boxes from flights 11 and 175 that hit the World Trade Center was ever-found. Airplane black boxes are designed to be "nearly indestructible." (ABC News, 9/17/01) A National Transportation Safety Board spokesman said, "It's extremely rare that we don't get the recorders back. I can't recall another domestic case in which we did not." (CBS, 2/23/02) The official story is that they were destroyed beyond recognition. But in 2004, The Philadelphia Daily printed a shocking story that was *not* picked up nationally. Using ATVs, "Two men who worked extensively in the wreckage of the World Trade Center claim they helped federal agents find three of the four 'black boxes' from the jetliners that struck the towers on 9/11 - contradicting the official account." (Philadelphia Daily, 10/28/04, Behind the Scenes Ground Zero, Pg 108, Counterpunch 12/19/05)
- ▶ No detailed information about the war games running on September 11th has been released. While media barely touched it, various military websites and press reports suggest that there were as many as six war games going on, and they may have included live-fly hijack scenarios, the deployment of North-East fighter jets out of the US to northern Canada and Alaska, and false radar blips inserted directly onto radar screens. (More Details, Ruppert, *Crossing The Rubicon*, Chapter 19, Iannewsletter, 9/98) At one point Jane Garvey, head of the FAA, claimed controllers were responding to 11 possible hijackings. (Richard Clarke, *Against All Enemies*, pp.4-5) Two hours after the first hijacking, the military was apparently still dealing with war games exercises. At 9:34, just before the 3rd plane hit, a technical sergeant instructed, "All surveillance, turn off your sim switches." And at 10:18, after the last crash, The Northeast Sector reported, "Confirmed that we have exercise stuff going out." They were instructed, "Confirm that you have all outputs to Cheyenne Mountain on the exercise turned off... and no more inputs on the exercise side. Is that understood?" (Northeast Air Defense Sector DRM1 DAT2 [audio file] Channels 2, 16, 9/11/01) Fake highjacks, inserts on radars, and diverted fighter jets - yet The 9/11 Commission only mentions one war game in one footnote, (9/11Commission Report ,p-458) and treats the others like they don't exist. Attempts by Congresswoman Cynthia McKinney and others to get information remained unsuccessful.
- ▶ Officials in New York City decided that audio and written records of the Fire Department on 9/11 should never be released to the public. (New York Times, 7/23/02) The NY Times sued under the Freedom of Information Act, and in 2005 the city was forced to release most of them. Many oral histories talk of explosions in the towers: "I saw a flash flash flash [at] the lower level of the building. You know like when they demolish a building?"--Assistant Fire Commissioner Stephen Gregory. "[I]t was [like a] professional demolition where they set the charges on certain floors and then you hear 'Pop, pop, pop, pop, pop'" -- Paramedic Daniel Rivera. "It seemed like it was going all the way around like a belt, all these explosions." -- Firefighter Richard Banaciski. Accounts of explosions given by witnesses in and around the towers were widely reported in the press on 9/11. But the stories were quickly dropped, and were not pursued by the Commission (Eye-witness video, written-NY Times 9/11 Records)
- ▶ FEMA investigators of the World Trade Center collapses had no subpoena power and little funding. They were prevented from interviewing some witnesses and severely limited in examining the disaster site. They were not able to obtain detailed blueprints of the buildings that collapsed! (New York Times, 12/25/01) Fire Engineering Magazine stated (January 2002), "Except for the marginal benefit" of "a three-day visual walk-through... no one's checking the evidence for anything," and concluded FEMA's investigation to be "a half-baked farce that may already have been commandeered by political forces."

- ▶ The wreckage from the World Trade Center was rapidly destroyed. Less than 2 weeks after the attacks, NYC accepted a proposal to recycle the steel from the collapsed buildings. Most of it was quickly cut up, shipped off, and melted down without proper documentation or forensic analysis, in violation of federal law. (New York Times, 12/25/01) While the steel was deemed of no use to investigators, it was considered important enough to equip all trucks with GPS locaters, at \$1000 apiece, so none of the steel was lost and its location was always known.
- ▶ WTC building #7, a 47-story steel-framed skyscraper which would be the tallest building in most American cities, mysteriously collapsed straight down into its footprint symmetrically at free-fall speed at 5:20 pm on September 11th. From an engineering viewpoint, this massive event, separate from the chaos of 9/11, would have dominated news. Yet the footage captured from several cameras was quickly purged from the mainstream media, and the government acted as if it had never happened. Two years later, most Americans still didn't even know a third building had come down. No steel-framed skyscraper in history has collapsed from fire. *Please view footage at: <https://rumble.com/v1jneyj-wtc-7-collapsed-at-520-pm-on-september-11-2001.-it-was-not-hit-by-a-plane..html>* The 9-11 Commission never mentions WTC 7's demise.
- ▶ The National Institute of Science & Technology (NIST) investigations are claimed to have closed the case on the collapses at Ground Zero, yet they were marked by obfuscation, omission and distortion; and their *ten-thousand page* report on the two towers ends before the point the buildings actually came down, not even attempting to explain the “global collapse” of each building in under 16 seconds! (911research.wtc7.net/essays/nist/)
- ▶ NIST said they found no evidence of explosives at ground zero. They later admitted they didn't test for them. Dr. John Gross at NIST claimed he was not aware of any eyewitness reports of molten steel. There were many recorded reports from firefighters *and* government. (molten steel, eyewitnesses) NIST, like the 9/11 Commission, was informed of eyewitness reports of explosions and melted steel, but wouldn't interview the witnesses or put out a general call for such witnesses.
- ▶ NIST investigators originally claimed that building #7 was not in “free fall”. “Free fall” is the speed an object falls in a vacuum, with no resistance. NIST used two data points in time to gauge the speed. An independent scientist using simple physics software showed a true, frame by frame calculation of the speed, proving over 100 feet of free fall, after which the NIST final report quietly admitted the free fall of building 7 for over 100 ft. But they don't admit in the report what they'd admitted earlier, before they were caught falsifying their data - that free fall means that over 100 ft of the building was **already gone** before the part we see in the video above was falling. It is not possible for the falling building to be crushing massive floors of steel and concrete below it, and falling through the air (free fall) at the same time. (See video link above)
- ▶ In other evidence highlights, the DoD destroyed evidence, the CIA destroyed 9/11 torture tapes before admitting they existed; NIST refused to release their computer model data for building #7; and gag orders or retaliation were put on Air Traffic Controllers, WTC Investigators, DoD Investigators, and whistleblowers Sibel Edmonds, Robert Wright , Lt. Col. Anthony Shaffer, J. Michael Springman and Indira Singh. Various investigative reports were not released for months / years / ever – for example, of 52 FAA security warnings, the ”28 pages” on Saudi/hijacker connections, the summary report of what Bush knew about al-Qaeda from his daily briefs, the workings of Dick Cheney's Energy Task Force; and SEC and data retrieval investigative results on pre-9/11 insider trading and World Trade Center money transfers on the morning of 9/11. And, the 9-11 Commission ignored almost everything on this flyer, and more.
